

**A RESOLUTION OF THE CITY COUNCIL AWARDING THE BIDS FOR ASPHALT SUPPLY FOR THE
REMAINDER OF 2022 THROUGH 2023 TO APAC CENTRAL INC., BLEVINS ASPHALT CONSTRUCTION CO.,
INC., CAPITAL MATERIALS, LLC., AND EMERY SAPP & SONS, INC.**

WHEREAS, the City of Republic, Missouri (“City” or “Republic”) is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the City recently solicited sealed bids for supplying the City its asphalt needs for the remainder of 2022 through 2023 (“Project”); and

WHEREAS, the City received four bids from the following companies: APAC Central Inc., Blevins Asphalt Construction Co., Inc., Capital Materials, LLC., and Emery Sapp & Sons, Inc.; and

WHEREAS, the City intends to approve all four entities who submitted a bid at the prices listed on their respective bids, each of which is attached hereto, and subsequently obtain the requested materials from the lowest bidder capable of providing said materials; and

WHEREAS, based on the recommendations of City staff, the Council finds that the Project may be awarded to APAC Central Inc., Blevins Asphalt Construction Co., Inc., Capital Materials, LLC., and Emery Sapp & Sons, Inc.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:

- Section 1:** The following four suppliers are awarded the Project at the rates shown in their respective bids, attached hereto and labeled consecutively as follows: APAC Central Inc. (“Exhibit 1”), Blevins Asphalt Construction Co., Inc. (“Exhibit 2”), Capital Materials, LLC (“Exhibit 3”), and Emery Sapp & Sons, Inc. (“Exhibit 4”). The City shall obtain the requested supplies from the lowest capable provider among the four suppliers approved herein.
- Section 2:** The City Administrator, and/or his designee, is authorized to take the necessary steps to execute this Resolution.
- Section 3:** The WHEREAS clauses are hereby specifically incorporated herein by reference.
- Section 4:** This Resolution shall become effective on and after the date of passage and approval as provided by law.
