Hot Mix temperature shall be a minimum of 375 degrees at the plant.

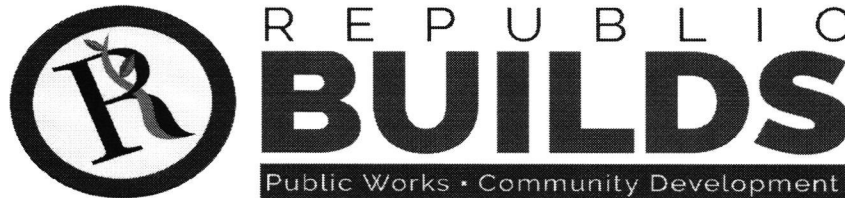
