

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI,  
AUTHORIZING AN APPLICATION FOR THE COST SHARE PROGRAM WITH THE  
MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION TO FUND  
TRANSPORTATION IMPROVEMENTS TO STATE HIGHWAY MM NORTH OF JAMES  
RIVER FREEWAY TO INTERSTATE 44**

*WHEREAS*, the City of Republic, Missouri (herein called “City” or “Republic”) is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized and existing under the laws of the State of Missouri; and

*WHEREAS*, the City’s BUILDS Department, in cooperation with other City Departments, wishes to apply for the Cost Share Program with The Missouri Highways and Transportation Commission in the amount of six million dollars to widen State Highway MM to five lanes north of James River Freeway to Interstate 44 (herein called the “Project”); and

*WHEREAS*, if awarded, the funds from this Cost Share Program will be used with other funding sources to secure financing to fund and expedite the Project; and

*WHEREAS*, the passage of this Resolution will authorize the City’s BUILDS Department and other City Departments to apply for the above-mentioned Cost Share Program; and

*WHEREAS*, the Council finds that participating in these opportunities will result in considerable savings to the City and increase safety and activities for our community and residents.

***NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:***

Section 1. The City Administrator, or designee, on behalf of the City, is authorized to apply for the above-mentioned Cost Share Program with The Missouri Highways and Transportation Commission for the Project.

Section 2. The City Administrator, or designee, on behalf of the City, is authorized to take the necessary steps to execute this Resolution.

Section 3. The whereas clauses are hereby specifically incorporated herein by reference.

Section 4. This Resolution shall take effect after passage as provided by law.
