Call Meeting to Order

The regular session meeting of the City Council of the City of Republic, Greene County, Missouri, was called to order by Mayor Matt Russell at 6:00 p.m. Council Members present included Eric Franklin, Garry Wilson, Eric Gerke, Chris Updike, Brandon Self, Gerry Pool, and Clint Gerlek. 8. 23-19 An Ordinance of the City Council Approving Amendment of the Zoning Classification of Approximately Seventeen Point One-Nine (17.19) Acres of Real Property Located at 3020 North York Avenue, from Agricultural (AG) to Heavy Industrial (M-2).

Motion was made by Council Member Updike and seconded by Council Member Franklin to have the second reading of Bill 23-19 by title only. Motion was made by Council Member Updike and seconded by Council Member Franklin to approve Resolution 23-R-42. Garrett Brickner provided an overview of the Resolution. The vote was 7 Aye-Franklin, Gerke, Gerlek, Pool, Self, Updike, and Wilson. 0 Nay. Motion Carried.

18.23-R-43 A Resolution of the City Council Authorizing Execution of a Memorandum of Understanding with Modern Tractor Supply Company and Lawrence Lipscomb for City's Use of Certain Real Property as Youth Recreational League Practice Fields.

19.23-R-44 A Resolution of the City Council Authorizing the City Administrator to Extend its Services Contract With Redec, LLC for Professional Advisory Services.

Motion was made by Council Member Wilson and seconded by Council Member Updike to approve Resolution 23-R-44. Andrew Nelson provided an overview of the Resolution. The vote was 7 Aye-Franklin, Gerke, Gerlek, Pool, Self, Updike, and Wilson. 0 Nay. Motion Carried.

20.23-R-45 A Resolution of the City Council Authorizing the City Administrator to Execute a Fourth Addendum to the Agreement for Financial Consulting Services with Maximist, LLC.

Motion was made by Council Member Franklin and seconded by Council Member Self to approve Resolution 23-R-45. Bob Ford provided an overview of the Resolution. The vote was 7 Aye-Franklin, Gerke, Gerlek, Pool, Self, Updike, and Wilson. O Nay. Motion Carried.

Reports from Staff

City Administrator David Cameron reported it is good to be back and thanked everyone for attending tonight. Mr. Cameron commended staff for the great job tonight and noted a member of the Springfield City Council attended tonight in his capacity as an engineer. Mr. Cameron thanked the City of Springfield for partnering with us.

City Administrator David Cameron announced that Larry Lipscomb donated the property we are sitting on. Mr. Cameron acknowledged he has been good to our community, and it is great for him to offer his property for us to use for free. Andrew has worked with him out near the new park on projects as well. Mr. Cameron applauded staff for thinking outside of the box to lease land to save money rather than buying additional land. Mr. Cameron thanked Mr. Lipscomb and noted that Garrett was prepared with all the parking data.

City Administrator David Cameron reported we received an additional 25-million-dollar allocation from the state legislature for our wastewater treatment plant expansion. Mr. Cameron noted this is a huge win for the community, but we still need 36 million dollars to complete this project. Mr. Cameron shared his first email upon returning to the office is in the Administrator's Report regarding an Anti-Degradation Report from Missouri Department of Natural Resources, which will be made public. This project impacts our residents' utility bills and shows actual costs. Mr. Cameron reported we have until July 28, 2023, to provide comments, noting our outside legal counsel for environmental law issues is helping with the comment. Mr. Cameron added we continue to work for additional funding and advocate for our citizens. Mr. Cameron commended the staff and Mayor Russell for all that has been accomplished. Mr. Cameron reported we will be going back for the next legislative session to request additional funds.



City Administrator David Cameron announced that tonight is Andrew Nelson's last night with us. Mr. Cameron shared he will never forget during Covid when we had to freeze hiring, Andrew walked in and reported he was willing to step into any position needed. Mr. Cameron thanked Andrew, adding this community thanks you for saving them money and bringing in a lot of projects. Andrew is a local kid and has been a blessing to the employees and community. Mr. Cameron acknowledged Andrew deserves this opportunity and is happy for him and his family.

Council Member Franklin noted it is tough to follow that and echoed everything David shared. Mr. Franklin noted he appreciates all the conversations and Andrew will be missed. Mr. Franklin thanked everyone that played a role in Have-A-Blast, noting he enjoyed the crowd, food, fun times, and is thankful for it all. Mr. Franklin added he appreciates all the volunteers.

Council Member Self echoed David's statements about Andrew, noting he was at the first lunch meeting with Andrew and has seen his growth since then. Mr. Self noted that time flies and he wishes Andrew the best.

Council Member Gerlek noted that Andrew never came off as the assistant to anyone and it is not a surprise for him to have bigger opportunities ahead. Mr. Gerlek noted Andrew did a lot for this community.

Mayor Russell noted he has been in the trenches with Andrew, and he has done some great things. Mayor Russell shared he is proud to call Andrew a friend. Mayor Russell noted he is not surprised this opportunity was presented to him and Andrew deserves it; it is just sad for us. Mayor Russell reported that as Mayor, he is still a husband and father first. Mayor Russell noted that during the next City Council meeting, his youngest son has 6th grade orientation, and the following meeting will be his 7th grader's first football game. Mayor Russell reported he often must decide whether to attend his family's activities or fulfill his commitment to attend meetings as Mayor. Mayor Russell reported he must put his family first and will not be running for Mayor next year but will finish out his term. Mayor Russell noted there will be 7 Council seats as well as Mayor on the ballot at the next election.
