

**A RESOLUTION OF THE CITY COUNCIL AUTHORIZING EXPENDITURES RELATING TO TWO MISSOURI  
DEPARTMENT OF PUBLIC SAFETY ARPA GRANT AWARDS**

**WHEREAS**, the City of Republic, Missouri, (“City” or “Republic”) is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

**WHEREAS**, the Fire Department was awarded the ARPA Emergency Medical Services Providers Grant from the Missouri Department of Public Safety for the purchase of two AED devices and an extrication tool in the amount of \$17,774.00; and

**WHEREAS**, the Fire Department was also awarded the ARPA Fire Protection Grant from the Missouri Department of Public Safety for the purchase of two ProAir Paks in the amount of \$25,107.84; and

**WHEREAS**, the Fire Department must purchase the items to be reimbursed for the awarded amount as part of the grant; and

**WHEREAS**, the Fire Department was able to utilize the Missouri State Commodity Contracts bid pricing; and

**WHEREAS**, the cost of the items has increased since the grant application and now exceeds the awarded amount with the possibility of amending the grant amount to offset the increases; and

**WHEREAS**, the Council find the purchase of the items will improve the scope and quality of services the Fire Department is able to provide the citizens of Republic, and thus is in the best interests of the citizens.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:**

- Section 1.** The City Administrator, or his designee, is authorized to purchase 2-LIFEPAK 1000 AEDs with adult and infant/child electrode, a Genesis E-Force 17C Combi Extrication Tool with batteries and attachments, and 2-Scott X3 Pro Air Paks and bottles at the cost of \$39,273.84, to later be submitted for reimbursement through the ARPA Fire Protection Grant and ARPA Emergency Medical Service Providers Grant.
- Section 2.** The City Administrator, or his designee, on behalf of the City, is authorized to take the necessary steps to implement this Resolution.
- Section 3.** The WHEREAS clauses are hereby specifically incorporated herein by reference.
- Section 4.** This Resolution shall become effective on and after the date of passage and approval as provided by law.
