

A RESOLUTION OF THE CITY COUNCIL APPROVING A LIST OF QUALIFIED PROFESSIONAL ENGINEERING FIRMS FOR AS-NEEDED USE FROM 2025 TO 2026

WHEREAS, the City of Republic, Missouri (“City” or “Republic”) is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the City issued a Request for Qualifications (RFQ) to engineering firms in September of 2024; and

WHEREAS, the City received submissions from eighteen (18) professional engineering firms (“Firms”), all of which were determined to be qualified bidders, able to meet the City’s needs as set forth in the RFQ; and

WHEREAS, the City desires to place all Firms on an approved vendor list for providing the City with engineering services, on an as-needed basis from January 1, 2025 until December 31, 2026; and

WHEREAS, based upon staff recommendations, the Council finds it in the best interest of the City and its citizens to approve the list of professional engineering firms demonstrating the qualifications to meet the City’s needs, as defined in its RFQ, on an as-needed basis until December 31, 2026.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:

Section 1: The City Administrator, and/or his/her designee(s), is hereby authorized to approve a list of professional engineering firms demonstrating the qualifications to meet the City’s needs as defined in its RFQ, on an as-needed basis for the years 2023 and 2024, to include the following: Bartlett and West, BUF Studio, Burns and McDonnell, Cook, Flatt & Strobel Engineers, Cochran, GBA, Global Precision Surveying, Great River Engineering, Gredell Engineering Resources, Lee Engineering and Associates, Olsson, OWN, Palmerton and Parrish, SCS Engineers, Terracon, Toth and Associates, Traffic Engineering Consultants, and Wilson and Company.

Section 2: The City Administrator, and/or his/her designee, is authorized to take the necessary steps to execute this Resolution.

Section 3: The WHEREAS clauses are hereby specifically incorporated herein by reference.

Section 4: This Resolution shall become effective on and after the date of passage and approval as provided by law.
