Background: Wisconsin state law mandates that assessors maintain their assessments within a 10% range of the state's equalized value at least once every four years. This requirement ensures fairness and equity in property tax distribution across the state. Failure to comply with this regulation can result in non-compliance letters from the Department of Revenue (DOR) and may necessitate a full revaluation.

To date, the City has received two non-compliance letters from DOR making a city-wide revaluation not only necessary but a high priority. The frequency at which municipalities choose to conduct revaluations varies, but a five-year interval is typical. The City last underwent a revaluation in 2008.

The City contracted Vierbicher to complete a request for proposal (RFP) process to solicit revaluation services. Three vendors inquired about the RFP but only one vendor, Accurate Appraisals LLC, submitted a proposal. After conducting a review of the proposal, interviewing the vendor and placing reference calls, **Option 4** (detailed below) was selected as the recommendation.
