and coaches of minors. A copy of th	e background check shall be provided to the City. If requested, the City may
agree to do a background check for	an organization. A fee will be assessed for this service.
Organizations may conduct their ow	n advertising and/or request the City do so on their behalf. A fee will be
assessed to the organization if the (City provides advertising services in the recreation guide.
The organization must collect all fee	es for their recreation programs.
All fees must be paid prior to service	e or use commencing.
The organization must pay the City	of Richland Center for use of City grounds and facilities according to the Fee
Schedule set by the City.	
Approvals for Sanctioned Recreation	n Groups are valid from the date of approval to December 31st at midnight of
the approval year. <u>Organizations mu</u>	ust seek renewal of approval on an annual basis.
