

VILLAGE OF OAKFIELD, WI

The Village of Oakfield, like many other small communities, continues to struggle with ways to finance street and utility projects. As municipal revenues stay level or increase slightly each year, the cost of making needed street and infrastructure improvements continues to rise and out-pace those revenues.

The most critical street and utility need in the Village of Oakfield pertained to a section of North Main Street from Church Street to the northern limits of the Village. North Main Street is also County Trunk Highway Y. Fond du Lac County had scheduled to improve CTH Y in 2019 and the Village needed to replace the utilities under this street.

In 2018, the Village of Oakfield turned to MSA for assistance. The Village, with MSA's assistance, conducted an income survey of the households along North Main to determine eligibility for the Community Development Block Grant for Public Facilities (CDBG-PF) program. The results of the survey indicated that the Village did qualify, and with MSA's assistance, submitted a grant application which was awarded that summer. The project was \$1.9 million and the Village received CDBG-PF funds amounting to \$500,000. The Village was left with funding the project at \$1.3 million.

In the fall of 2018, the Department of Administration rolled out the CDBG-CLOSE program. Fond du Lac County had approximately \$2.1 million available for projects. The portion of CTH Y (N. Main Street) in the Village of Oakfield qualified for CDBG-PF, and in April of 2019, Fond du Lac County approved allocating \$1.0 million of their CDBG-CLOSE funds to the Village of Oakfield North Main Street and Utility Project.

MSA provided grant application and administration for the project.

ROBERT STREET AND WEST 12[™] STREET

CLINTONVILLE, WAUPACA COUNTY, WI

The City of Clintonville's pavement on both roadways was in very poor condition and had reached the end of its useful life. The drainage system lacked capacity to adequately handle even a normal stormwater run-off, and the utilities were old and failing.

MSA funding experts helped secure \$1,218,310 in grants for this \$2 million project. The balance is being funded through lowinterest loans provided by the Safe Drinking Water Loan Program and the Clean Water Fund Program.

The City hired MSA to plan, design and secure funding for roadway, drainage, and collection system improvements for both Robert Street and W. 12th Street. By combining these two projects, the City was able to gain efficiencies in making upgrades to their sewer collection system, water distribution, roadway and storm sewer infrastructure.

MSA played a vital role in coordinating with City officials,

CITY OF CRANDON, WI

The City of Crandon, like many other small communities, continues to struggle with ways to finance street and utility projects. As municipal revenues remain level or increase slightly each year, the cost of making necessary street and infrastructure improvements continues to rise, outpacing those revenues.

The most recent street and utility need in the City of Crandon pertained to a section of East Polk Street from S. Park Avenue to E. Glen Street. Critical public utilities, such as the main sanitary sewer interceptor carrying 95% of the wastewater to the treatment plant, were failing. Without repair, these issues could have led to catastrophic consequences.

In 2020, the City of Crandon turned to MSA for assistance. With MSA's support, the City determined community-wide eligibility for the Community Development Block Grant Public Facilities (CDBG-PF) program. With this determination, MSA, on behalf of the City, submitted a grant application for the project. The City was awarded a grant of \$1,000,000 in CDBG-PF dollars.

The total project costs amounted to \$3.4 million, leaving the City responsible for funding \$2.4 million of the project. MSA continued to assist the City in securing as much funding as possible. This led to WDNR State Revolving Fund applications through the Safe Drinking Water Loan Program (SDWLP) and Clean Water Fund Program (CWFP). The City was eligible for 60% Principal Forgiveness (PF). When the final funding list was released, the City received \$788,546 in PF through the SDWLP and \$621,659 in PF through the CWFP, totaling roughly \$1.4 million in grant dollars from the WDNR SRF Program.

The remaining \$880,000 became a WDNR loan through these programs at the low interest rate of 1.287%, leaving the City of Crandon with \$120,000 to be covered by their internal funds.

MSA provided grant application and administration services for the entire project.
