A RESOLUTION AMENDING VILLAGE ORDINANCE 1.10 FORMAL ADOPTION OF A COMPREHENSIVE PLAN

The purpose of this resolution is for the Village of Ridgeway, Iowa County, Wisconsin, to lawfully adopt a comprehensive plan as required under [66.1001 \(4\) \(c\)](#), of the Wisconsin Statutes.

WHEREAS, the Village of Ridgeway, pursuant to the provisions of Sections 62.23, 61.35 and 60.22 (3) of the Wisconsin Statutes, has authority under its adopted village powers and has created a Village Plan Commission; and

WHEREAS, it is the duty and function of the Village Plan Commission, pursuant to Section 62.23 (2) of the Wisconsin Statutes, to amend a comprehensive plan for the development of the village, and to recommend that the Village Board adopt the Comprehensive Plan; and

WHEREAS, the Village Plan Commission has prepared a plan titled Village of Ridgeway, Wisconsin Comprehensive Plan Update 2018 from the original plan passed in 2005; as adopted May 8, 2018, and further revised, updated, and approved by the Village Plan Commission on April 7, 2021 and the Village Board on April 13, 2021; and

WHEREAS, the Village of Ridgeway, Wisconsin Comprehensive Plan includes the following nine elements: Issues and Opportunities; Land Use; Housing; Transportation; Utilities and Community Facilities; Agricultural; Natural and Cultural Resources; Economic Development; Intergovernmental Cooperation; and Implementation; and

WHEREAS, the Village of Ridgeway Plan Commission conducted public participation, a public survey, and a public hearing held on April 7, 2021 with meetings and public participation activities throughout the course of development of the Comprehensive Plan following the procedures set forth in Section 66.1001 (4) (d) of the Wisconsin Statutes; and

WHEREAS, the Village of Ridgeway Plan Commission by majority vote on April 7, 2021; recorded in the official minutes, has recommended to the Village Board the adoption of the document titled Village of Ridgeway Comprehensive Plan.

NOW THEREFORE, BE IT RESOLVED, that pursuant to Sections 62.23(3)(b) and 66.1001(4)(b) of the Wisconsin Statutes, the Village of Ridgeway Board of Trustees hereby adopts the document titled Village of Ridgeway, Wisconsin Comprehensive Plan, with the Issues and Opportunities; Land Use; Housing; Transportation; Utilities and Community Facilities; Agricultural; Natural and Cultural Resources; Economic Development; Intergovernmental Cooperation; and Implementation elements; the Zoning Map, Future Land Use Plan Map and appendices contained in the comprehensive plan available on the village website and in the village clerk's office; and

THEREFORE, BE IT FUTHER RESOLVED, that Village Ordinance 1.10 be revised to read:

1.10 FORMAL ADOPTION OF A COMPREHENSIVE PLAN.

(Cr. March 1, 2005) (Eff. March 2, 2005) (Amended April 10, 2023)

(1) Pursuant to sections 62.23(2) and (3), for cities, villages, and towns exercising village powers under 60.22(3) of the Wisconsin Statutes, the Village of Ridgeway, is authorized to prepare and adopt a comprehensive plan as defined in section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

(2) The Plan Commission of the Village of Ridgeway, by a majority vote of the commission, recorded in its official minutes of April 7, 2021, has recommended approval of the Village of Ridgeway, Wisconsin Comprehensive Plan (Update 2021).

(3) The Village of Ridgeway has held at least one public hearing on the Comprehensive Plan updates, with notice in compliance with the requirements section [66.1001 \(4\) \(d\)](#), of the Wisconsin Statutes.

(4) The village board, by the enactment of this ordinance, formally adopts the document entitled Village of Ridgeway, Wisconsin Comprehensive Plan (Update 2021) pursuant to section [66.1001 \(4\) \(c\)](#), of the Wisconsin Statutes.

(5) If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

(6) This ordinance shall take effect upon passage by a majority vote of the members elect of the Village Board and publication as required under section [60.80](#), of the Wisconsin Statutes. A copy of the ordinance and the comprehensive plan, shall be filed with at least all of the entities specified under section [66.1001 \(4\) \(b\)](#), of the Wisconsin Statutes.
