Dear VILLAGE OF RIDGEWAY,

Jewell Associates Engineers Inc., has been hired by the Iowa County Highway Department to develop roadway plans for the reconstruction of approximately 4,200 feet of CTH HHH (Main Street). The project begins at the intersection of CTH HHH/Level Street and continues northeast to the intersection of CTH HHH/CTH H (North). The project is located in Sections 11, 14, and 15, T6N, R4E, in the Village of Ridgeway, Iowa County. The proposed plan will consist of the complete reconstruction of CTH HHH including replacing the existing pavement structure, concrete curb and gutter, storm sewer, concrete sidewalk, and improving drainage throughout the project corridor. Improvements to sideroad intersections with minor horizontal and vertical deficiencies are anticipated. The village will be evaluating the inclusion of community sensitive design elements as part of this project (decorative lighting, pedestrian uses, crosswalks, benches, parking, street connections, on-street parking, landscaping, and beautification elements). The village is also planning water and sanitary sewer improvements as part of this project. CTH HHH will be closed to thru traffic during construction operations (access will be maintained for businesses/landowners located within the project limits throughout construction).

In the near future several field crews will be on site collecting information about the CTH HHH corridor. They include survey crews (collecting topographic data), archaeological/historical (fall, 2025), and geotechnical (soil borings – storm sewer, retaining walls, and hazardous materials; spring, 2026). Some of this data that will be collected requires entering onto adjacent property. We understand that you own adjacent property to the CTH HHH corridor. This letter is to inform you of the potential of field crews entering onto your property that abuts the CTH HHH corridor to collect their information for the design of the CTH HHH project.

We are at the initial stages of the design of this project. We plan on holding a public involvement meeting January/February, 2026 to acquaint the public with project concepts/impacts. A letter will be sent to you inviting you to that meeting once scheduled. The Village of Ridgeway Board has created a steering committee to discuss various aspects of the project with regards to the beautification process for the corridor. Questions related to the work of the steering committee can be directed to the Village Clerk. Questions with regards to the sanitary sewer and water main improvement portion of the project can be directed to the Village PW Director or Village Engineer Bart Nies with Delta 3.






