DRAFT Meeting Minutes

Meeting Date: Thursday, December 8, 2022 at 12:00 p.m., Remote Meeting via Zoom

Call to Order: Council President W. Alexopoulos called the meeting to order.

Old/Unfinished Business:

1. Town of Randolph Complete Streets Policy

Council President Alexopoulos explained we had a presentation regarding this matter on Monday, 12/5/2022, from BETA Engineering and Planning Director Michelle Tyler and DPW Superintendent Chris Pelitterri. I would like to vote on this matter, the Complete Streets Policy as presented on Monday evening with the Resolution format. The only difference is the effective date which is December 8, 2022 instead of December 5, 2022. I would also like to forward the maps and drawings that have been taken over the last 5-7 years from the different phases of planning to the Public Safety Subcommittee because things change and we want to make sure we are current in our priorities. All of the Councillors are invited to attend the subcommittee meeting and voice their opinions.

Councillor Brewer: This is an excellent explanation of taking the maps and drawings that have been done in the past and evaluating them to see if we can include them. If we can, then we'll include them.

Councillor Huff-Larmond: Excellent idea, I would only ask if Public Safety could put together a date sooner rather than later.

Councillor Gordon: What is the status of Council Order 2022-058 regarding the Town Council having input on the prioritization prior to it being sent to the state?

Council President Alexopoulos indicated that that is the purpose of sending that Council Order to the Public Safety Subcommittee, so the Town Council will be able to prioritize the drawings before they're submitted.

Councillor Gordon: For that purpose, I think we'll call off the Special Council Meeting that had been proposed for Monday, if that's the proper procedure.

Town Attorney Griffin: The procedure is that three Councillors are required to call the special meeting. If three Councillors no longer want to have the meeting then any one or more of the three Councillors can ask that their name be removed from that list.

Motion made by Councillor O'Connell to approve the Complete Streets Policy as presented with an effective date of 12/8/2022, instead of 12/5/2022. Seconded by Councillor Brewer.

Roll Call Vote: 7-0-0 (Burgess and Egan Absent)

Motion passes.

Motion made by Council Vice President Clerger to forward the drawings for review to the Public Safety Subcommittee, seconded by Councillor C. Alexopoulos.

Roll Call 7-0-0 (Burgess and Egan Absent)

Motion passes.
