PROJECTS/EFFORTS

1. FEMA Hurricane Florence Recovery Projects (3)

- a. Monthly progress meetings complete.
 - (1) *Main Pump Station*-Awaiting final payout. Conducted another Team meeting with FEMA confirm admin completion. Also submitted reimbursement costs for management fees adding to \$97,000.
 - (2) Wastewater Treatment Plant- Awaiting final payout from FEMA.
 - (3) Low Water Crossing- Awaiting final payout from FEMA.

DEPARTMENT REPORTS

1. ADMINISTRATIVE

- a. Spoke with Duke Energy about installing a timer on lights at Millikan. We'll get an estimate from the electrician to add timer to lights.
- b. Spoke with Republic about Commercial Trash Cans pickup.

General Assembly in House Bill 205 may require each member of the Governing Board and the Administrator to complete financial management education in the amount of 6 hours, if Town is on the UAL list. Also, there is a time limit it has to be started unless they have completed it within 24 months.
