AN ORDINANCE APPROVING A SPECIAL USE AND VARIATION OF CODE FOR SIGNAGE LOCATED AT 407 LINCOLN HIGHWAY, ROCHELLE, ILLINOIS

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permits . . . A local ordinance may impose more rigorous or definite regulations in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton*, 291 Ill. App. 3d 1058, 1060 (1997)); and

WHEREAS, on August 1, 2022 the City's Planning and Zoning Commission ("PZC") conducted a public hearing on PZC-11-22 relative to a request received by Teresa Petry ("Petitioner") for a special use permit for a three-dimensional, lighted roof top sign on the back of 407 Lincoln Highway, Rochelle, Illinois, as well as a variation from the requirements of Section 110-365 (10) of the Rochelle Municipal Code; and

WHEREAS, Petitioner, seeking a Special Use Permit and variation to allow for said roof sign and larger signage on the front awning in the B-1 Central Commercial District at 407 Lincoln Highway, Rochelle, Illinois 61068 ("Subject Property") in Downtown Rochelle; and

WHEREAS, public notice in the form required by law was given of said public hearing by publication not more than thirty (30) days nor less than fifteen (15) days prior to said public hearing; and

WHEREAS, pursuant to Section 74-33, 74-34 and 110-101 of the City Code, the Planning and Zoning Commission has the authority to review and recommend a petition for Special Use Permits and Variations related to accessory buildings to the Mayor and City Council; and

WHEREAS, the PZC voted 7-0 to recommend approval of the Special Use Permit and variation to allow for the three-dimensional, lighted roof top sign at the Subject Property and voted 7-0 for a variation of the sign on the front awning; and

WHEREAS, the PZC has filed its report of findings and recommendations regarding the approval of the Special Use Permit and variation to allow for the three-dimensional, lighted roof top sign and variation from the front awning signage requirements at the Subject Property with this Mayor and City Council, and this City Council has duly considered said report, findings, and recommendations; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to approve said Special Use Permit and variation; and

NOW THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of Rochelle, Ogle County, Illinois, as follows:

<u>SECTION ONE</u>: The foregoing recitals shall be, and are hereby, incorporated into and made a part of this Ordinance as if fully set forth in this Section One.

<u>SECTION TWO</u>: That the report of findings and recommendations of the PZC are herein incorporated by reference as the findings of this Mayor and City Council, as complete as is fully set forth herein at length. This City Council finds that the Petitioner has provided to establish that they have met the standards for granting of a Special Use Permit and variations of code as set forth in the Rochelle Municipal Code and Zoning Ordinance, and the proposed granting of the Special Use Permit in the B-1 Central Commercial District and variation, as set forth herein, is in the public good and in the best interest of the City and its residents and is consistent with and fosters the purpose and spirit of the City's Municipal Code and Zoning Ordinance.

<u>SECTION THREE</u>: The Special Use Permit set forth herein below shall be applicable to the following described Property,

LEGAL DESCRIPTION: ATTACHED HERETO AS EXHIBIT 1.

Commonly known as: 407 Lincoln Highway, Rochelle, Illinois 61068 ("Subject Property")

<u>SECTION FOUR</u>: That a Special Use Permit to allow for the installation of a three-dimensional, lighted roof top sign located at the back of the Subject Property is hereby granted to Petitioners. Per this Special Use, the roof sign will be a maximum of 1'6" tall X 10'0" wide

<u>SECTION FIVE</u>: The Variation set forth herein below shall be applicable to the Subject Property.

SECTION SIX. That the Variation at the Subject Property is granted as follows:

1.) Petitioner is granted a variation from section 110-369(2), which states that the maximum (Maximum of) Eighty (80%) percent of maximum area for copy and graphics on valance. Petitioner shall be allowed to place a sign on the front awning that is a maximum of 1'6" tall and 6' wide.

<u>SECTION SEVEN</u>: The City Clerk shall be and is hereby authorized and directed to cause a certified copy of this Ordinance with the attached <u>Exhibit A</u>, to be recorded in the Office of the Ogle County Recorder.

<u>SECTION EIGHT</u>: If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.

<u>SECTION NINE</u>: The City Clerk shall publish this Ordinance in pamphlet form.

<u>SECTION TEN</u>: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
