A RESOLUTION ACCEPTING THE BID PROPOSAL AND AUTHORIZING A CONTRACT WITH CURREN CONTRACTING

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permits . . . A local ordinance may impose more rigorous or definite regulations in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton*, 291 Ill. App. 3d 1058, 1060 (1997)); and

WHEREAS, on July 18th at 10:00 am the City publicly opened bids for the pavement surface removal and HMA resurfacing of North Pointe Street, the "Project Area" is depicted in Exhibit A attached herein; and

WHEREAS, the City received three bids, the lowest from Curren Contracting in the amount of \$147,246.02; and

WHEREAS, the proposal received from Curren Contracting meets all the requirements of the City's request and is approximately 15% lower than the Engineer's estimate of cost; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to accept the proposal, award the contract to Curren Contracting and authorize the payment of the bid amount of \$147,246.02, plus additional change order work funds, not to exceed \$22,000.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

<u>SECTION TWO</u>: The bid submitted by Curren Contracting in the amount of \$147,246.02 is accepted and payment is authorized. Furthermore, the City Manager or his designee is authorized to negotiate, approve and authorize additional improvements (contract change order) to City Streets adjacent to the project limits and within the LHP TIF zone in an amount not to exceed \$22,000, and sign any documents necessary to carry out the North Pointe Street repaying project, subject to review and revision by the City Attorney.

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Resolution will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
