## AN ORDINANCE APPROVING A SPECIAL USE PERMIT FOR AN ADULT-USE CANNABIS INFUSER AT 600 N. 15th STREET

**WHEREAS**, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

**WHEREAS**, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permits . . . A local ordinance may impose more rigorous or definite regulations in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton,* 291 III. App. 3d 1058, 1060 (1997)); and

**WHEREAS**, Petitioner, Stash Holding Corporation ("Petitioner") has submitted an application for a Special Use Permit at 600 N. 15<sup>th</sup> Street ("Subject Property"); and

**WHEREAS**, the legal description of the Subject Property is attached herein as Exhibit A; and

WHEREAS, the subject property is zoned I-2, General Industrial; and

**WHEREAS**, Petitioner is seeking a proposed special use permit to allow for an adult-use cannabis infuser organization at 600 N. 15<sup>th</sup> Street; and

**WHEREAS**, pursuant to Sec. 110-160 of the Zoning Ordinance, an adult-use cannabis infuser is only permitted in I-2 zoning with a special use permit; and

**WHEREAS**, all adult-use cannabis facilities must meet the conditions listed in Sec. 110-750 Adult-Use Cannabis; and

**WHEREAS,** in addition to meeting all the conditions listed in Sec. 110-750 of the Zoning Ordinance, petitioner must also submit a security plan approved by the City of Rochelle Police Department; and

**WHEREAS**, on December 1, 2025, the City's Planning and Zoning Commission ("PZC") conducted a public hearing on Petitioner's request for a Special Use Permit to operate a cannabis infuser at the Subject Property; and

**WHEREAS**, public notice in the form required by law was given of said public hearing by publication not more than thirty (30) days nor less than fifteen (15) days prior to said public hearing; and

**WHEREAS**, on December 1, 2025, the PZC voted 6-0 to recommend approval of the Special Use Permit to operate a cannabis infuser on the Subject Property, subject to the submission of a security plan approved by the Rochelle Police Department; and

**WHEREAS**, the PZC has filed its report of findings and recommendations regarding the approval of the Special Use Permit for the Subject Property with the Mayor and City Council, and the City Council has duly considered said report, findings, and recommendations; and

**WHEREAS**, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to grant Petitioner a Special Use Permit subject to the approval of the required security plan.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and City Council of the City of Rochelle, Ogle County, Illinois, as follows:

<u>SECTION ONE</u>: The foregoing recitals shall be, and are hereby, incorporated into and made a part of this Ordinance as if fully set forth in this Section One.

<u>SECTION TWO</u>: That the report of findings and recommendations of the PZC are herein incorporated by reference as the findings of the Mayor and City Council, as complete as is fully set forth herein at length. This City Council finds that the Petitioner has provided evidence to establish that it has met the standards for granting a Special Use Permit as set forth in the Rochelle Municipal Code and Zoning Ordinance, and granting of the Special Use Permit as set forth herein is in the best interest of the City and its residents and is consistent with and fosters the purpose and spirit of the City's Municipal Code and Zoning Ordinance.

<u>SECTION THREE</u>: That a Special Use Permit for the operation of an adult-use cannabis infuser at the Subject Property located at 600 N. 15<sup>th</sup> Street (and legally described in Exhibit A) shall be granted subject to a security plan being approved by the Rochelle Police Department.

<u>SECTION FOUR</u>: If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without

the invalid application or provision, a	nd each invalid provision	or invalid application of this
Ordinance is severable.	-	

<u>SECTION FIVE</u>: Where the conditions imposed by any provisions of this Ordinance are more restrictive than comparable provisions imposed by Ordinance in any other local law, ordinance, resolution, rule or regulation, the regulations of this Ordinance will govern.

SECTION SIX: The City Clerk shall publish this Ordinance in pamphlet form.

<u>SECTION SEVEN</u>: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
