A RESOLUTION ELIMINATING CERTAIN BOARDS AND COMMITTEES

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, the City of Rochelle ("City") has various committees and commissions for some of its enterprises and to address other issues in the community; and

WHEREAS, the City's staff has reviewed the activity of certain committees and commissions and recommends that certain committees and commission be eliminated; and

WHEREAS, Section 2-291 of the City of Rochelle's City Code empowers the City Council to establish or abolish certain advisory boards by resolution; and

WHEREAS, the City Council has found that the Trucking Advisory Committee, Utility Advisory Board, Stormwater Advisory Commission; and Railroad Advisory Board are no longer needed for the operation of the City's business; and

WHEREAS, it has been determined by the Mayor and the City Council of the City that it is in the best interest of the City and its residents to eliminate the Trucking Advisory Committee, Utility Advisory Board, Stormwater Advisory Commission, Airport Advisory Board, and Railroad Advisory Board and all sections of the municipal code related to these committees and commissions; and

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Rochelle, Ogle County, Illinois, as follows:

<u>SECTION ONE</u>: The foregoing recitals shall be, and are hereby, incorporated into and made a part of this Resolution as if fully set forth in this Section One.

<u>SECTION TWO</u>: That the Mayor and City Council of the City of Rochelle hereby eliminate the Trucking Advisory Committee, Utility Advisory Board, Stormwater Advisory Commission, Airport Advisory Board, and Railroad Advisory Board and all sections of the municipal code

related to these committees and commissions, including, but not limited to, Section 94-542 of the City of Rochelle's City Code entitled, "Trucking Advisory Committee".

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed by Resolution in any other local law, ordinance, resolution, rule or regulation, the regulations of this Resolution will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
