ORDINANCE abating the taxes heretofore levied for the year 2023 to pay debt service on General Obligation Bonds (Alternate Revenue Source), Series 2023A, of the City of Rochelle, Ogle and Lee Counties, Illinois.

WHEREAS, the City of Rochelle, Ogle and Lee Counties, Illinois (the "City"), an Illinois municipal corporation, currently has outstanding General Obligation Bonds (Alternate Revenue Source), Series 2023A (the "2023A Bonds"); and

WHEREAS, the City has Pledged Revenues (as defined in the ordinance authorizing the issuance of the 2023A Bonds (the "Ordinance")) on deposit in the Bond Fund (as defined in the Ordinance) available for the purpose of paying debt service on the 2023A Bonds heretofore imposed by the 2023 levy; and

WHEREAS, such Pledged Revenues are hereby directed to be used for the purpose of paying debt service on the 2023A Bonds; and

WHEREAS, it is necessary and in the best interests of the City that the taxes heretofore levied for the year 2023 to pay the 2023A Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Ordained by the City Council of the City of Rochelle, Ogle and Lee Counties, Illinois, as follows:

Section 1. Abatement of Taxes. The taxes heretofore levied for the year 2023 in the Ordinance are hereby abated in their entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this abatement ordinance, the City Clerk of the City shall file a certified copy hereof with the County Clerks of the Counties of Ogle and Lee, Illinois (the "County Clerks"), and it shall be the duty of the

County Clerks to abate said taxes levied for the year 2023 in accordance with the provisions hereof.

Section 3. <u>Effective Date</u>. This abatement ordinance shall be in full force and effect forthwith upon its adoption.
