**RESOLUTION RATIFYING EMERGENCY EXPENDITURE FOR THE
PURCHASE OF 35KV 750 MCM ALUMINUM WIRE FROM UUSCO**

RESOLUTION NO. _____

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle (“City”), Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to “pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities.” 65 ILCS 5/1-2-1; and

WHEREAS, City of Rochelle (“the City”) currently operate an electric distribution utility through the Rochelle Municipal Utilities (“RMU”), one of its departments; and

WHEREAS, the City previously authorized the purchase of a 35KV distribution cable for a new distribution feeder that would service Project Jackpot from the RMU’s new substation; and

WHEREAS, the City has certain deadlines to provide power to Project Jackpot; however, the previously order distribution feeder cable would not be available in time for the City to meet its contractual obligations; and

WHEREAS, RMU staff was able to source a compatible feeder cable from UUSCO that would allow the RMU to meet its deadlines pursuant to the Redevelopment Agreement with Project Jackpot; and

WHEREAS, RMU staff ordered the additional 750 MCM Aluminum Wire from UUSCO in the amount of \$147,960.00, so that the City could meet its obligations pursuant to the Redevelopment Agreement with Project Jackpot; and

WHEREAS, the City Manager accepted the quote from UUSCO for the purchase of the 35KV 750 MCM distribution cable, attached hereto as Exhibit 1; and

WHEREAS, the City Manager has the authority to execute agreements when circumstances create a public emergency pursuant to Section 2-107 of the Rochelle Municipal Code; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to ratify emergency expenditure for the emergency purchase of 35KV 750MCM distribution cable from UUSCO; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ROCHELLE, ILLINOIS as follows:

SECTION ONE: The foregoing Recitals are not mere preparatory language, but are hereby incorporated in this Section 1 as if said Recitals were fully set forth.

SECTION TWO: The Mayor and City Council hereby ratify the City Manager emergency expenditure for the emergency expenditure for the emergency purchase of 35KV 750MCM distribution cable from UUSCO, attached hereto as Exhibit 1.

SECTION THREE: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

SECTION FOUR: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Resolution will govern.

SECTION FIVE: The City Clerk shall publish this Resolution in pamphlet form.

SECTION SIX: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
