A RESOLUTION APPROVING SUPPORT AND COMMITMENT OF LOCAL FUNDS

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle ("City"), Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, the City and the Rochelle Municipal Utilities need to line the sanitary sewers in a residential neighborhood in southeast Rochelle to meet their customers' needs; and

WHEREAS, the sanitary sewer relining will cost approximately \$1,322,200; and

WHEREAS, City Staff and City Manager are in the process of applying to the State of Illinois for a Community Development Block Grant ("CDBG") Program grant as a grantee to defray some of these costs; and

WHEREAS, it is necessary that an application be made and agreements be entered into with the State of Illinois for the CDBG Program; and

WHEREAS, the criteria of CDBG Program are such that financial participation by the grantee is required in conjunction with an award of CDBG Program grant funds; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to apply for a CDBG Program and commit funds to obtain the grant; and

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

<u>SECTION TWO</u>: Whereas, in order to obtain the CDBG Program grant, the City Manager and Clerk are authorized to do the following:

- A) To apply for a grant funds under the terms and conditions of the State of Illinois for the CDBG Program and shall enter into and agree to the understandings and assurances contained in said application.
- B) To execute on behalf of the City such documents and all other documents necessary for the carrying out of said application.
- C) To provide such additional information as may be required to obtain the CDBG Program grant.
- D) To represent in the City's application and commit funds from the Rochelle Municipal Utilities Water Reclamation Fund that would be used to line sanitary sewers in a residential neighborhood in southeast Rochelle, such funds to equal 22.69% of the project's estimated total construction cost of \$1,322,200, or \$300,000.

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, resolution, resolution, rule or regulation, the regulations of this Resolution will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
