A RESOLUTION WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE PURCHASE OF HYLITE POLES AND FIXTURES FROM WESCO DISTRIBUTION

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulation proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permit. A local ordinance may impose more rigorous or definite regulation in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton*, 291 Ill. App. 3d 1058, 1060 (1997)); and

WHEREAS, the Rochelle little league approached Rochelle Municipal Utilities (RMU) to assist in a lighting upgrade for the softball field; and

WHEREAS, the total cost of the light fixtures and poles is \$46,865.00; and

WHEREAS, the proposed agreement is that the City, Park District and Rochelle Little League will each be responsible for \$15,621.67; and

WHEREAS, the Rochelle Little League delivered an \$8,000 check as the down payment on their portion, and will fundraise and submit grant applications to reimburse the City for the remainder of its portion of the lights, and

WHEREAS, the City will invoice the Park District in early 2025 for their full contribution of \$15,621.67; and

WHEREAS, the City will invoice the Little League in early 2026 for the remaining \$7,621.67; and

WHEREAS, Wesco has provided a quote (see attached Exhibit A) for the little league poles and light fixtures; and

WHEREAS, the City may waive competitive bidding requirements by a two-thirds vote of the City Council pursuant to 65 ILCS 5/8-9-1 of the Illinois Municipal Code and Section 2-371 of the Rochelle Municipal Code; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to waive the competitive bidding requirements and approve the purchase of lighting fixtures and poles from Wesco in the amount of is \$46,865.00 for the Rochelle Little League softball field.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

<u>SECTION TWO</u>: The Mayor and City Council of the City of Rochelle hereby waive the competitive bidding requirements and approve the purchase of lighting and poles from Wesco, in the amount of is \$46,865.00 for the Rochelle Little League softball field. Furthermore, the City Attorney shall prepare a cost sharing agreement for execution between the City, the Park District and the Rochelle Little League. The City Manager is authorized to execute any documents necessary to carry out the intent of this Resolution, subject to review and revision by the City attorney.

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Resolution will govern.

SECTION FIVE: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
