### RESOLUTION WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE TRADE-IN OF A 2009 FREIGHTLINDER AND THE PURCHASE OF A 2020 KENWORTH T880

**WHEREAS**, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

**WHEREAS**, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

**WHEREAS**, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permits . . . A local ordinance may impose more rigorous or definite regulations in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton,* 291 Ill. App. 3d 1058, 1060 (1997)); and

**WHEREAS**, the City of Rochelle Public Works Department utilizes semi-trucks to transport many different types of materials, equipment, and supplies to and from construction sites; and

**WHEREAS**, the Public Works department is seeking to trade-in its 2009 semi-truck for a newer, more reliable and cost-effective semi-truck; and

WHEREAS, Public Works has determined that its 2009 Freightliner Classic is no longer reliable; and

**WHEREAS**, CIT Trucks has offered to purchase the City's 2009 Freightliner Classic for \$8,500 (see attached Exhibit A); and

**WHEREAS**, the City is interested in purchasing CIT Truck's 2020 Kenworth T880 which has 379,215 miles, a new 455 hp Paccar MX-13 diesel engine, Allison 4500 RDS automatic transmission, and a dual line wet kit, for \$85,473.00; and

**WHEREAS**, the City may waive competitive bidding requirements by a two-thirds vote of the City Council pursuant to 65 ILCS 5/8-9-1 of the Illinois Municipal Code and Section 2-371 of the Rochelle Municipal Code; and

**WHEREAS**, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to waive competitive bidding and approve the purchase of a used 2020 Kenworth T880 in the amount of \$85,473.00 and authorize the tradein of a 2009 Freightliner Classic semi-truck for \$8,500 with CIT Trucks for a total cost of \$76,973.

# BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

<u>SECTION TWO</u>: The Mayor and City Council of the City of Rochelle hereby waive competitive bidding and approve the purchase of one 2020 Kenworth T880 in the amount of \$85,473.00 and authorize the trade in of 2009 Freightliner Classic semi-truck for \$8,500 from CIT Trucks for a total cost of \$76,973. The City Manager is hereby authorized to execute a purchase order consistent with the terms of this Resolution, subject to review and revision as to form by the City Attorney.

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Resolution will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
