A RESOLUTION APPOINTING AN AUTHORIZED AGENT FOR THE ILLINOIS MUNICIPAL RETIREMENT SYSTEM

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle ("City"), Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, the City of Rochelle is a participant in the Illinois Municipal Retirement System (IMRF), and;

WHEREAS, by law the City is required to have an authorized IMRF agent; and

WHEREAS, the City's Finance Director, Matt Hoffman should be designated at the City's authorized IMRF agent.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Rochelle that:

<u>SECTION ONE</u>: Matt Hoffman is hereby appointed as the City of Rochelle's authorized agent.

<u>SECTION TWO</u>: The authorized agent is granted the powers and duties as provided by law to administer the City's IMRF system and to exercise the powers and duties pertaining to nomination and election of trustees of IMRF.

<u>SECTION THREE</u>: This appointment is effective immediately, as of November 10, 2025.
