RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT THE PROPOSAL OF AND EXECUTE AN AGREEMENT WITH TURNER'S CUSTOM CONCRETE

WHEREAS, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/11-1, et seq.; and

WHEREAS, the City of Rochelle owns and operates a water and water reclamation utility thought the Rochelle Municipal Utilities ("RMU"), one of its departments; and

WHEREAS, the RMU constructed a new water well, Well 4; and

WHEREAS, as part of the construction of the new Well 4, the RMU installed a new watermain, which required the demotion of approximately 1600 square feet of roadway, as well as the demolition of curbs and sidewalks; and

WHEREAS, the RMU's staff solicited bids for the replacement of the aforementioned concrete infrastructure; and

WHEREAS, the RMU staff received two bids for the concrete restoration work; and

WHEREAS, Turner's Custom Concrete provided the low proposal in the amount of \$24,900, attached hereto as Exhibit 1; and

WHEREAS, Section 2-371 of the City of Rochelle's Municipal Code allows the City Manager to award contracts without competitive bidding; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to accept the proposal of and execute an agreement with Turner's Custom Concrete, pursuant to its proposal, attached hereto as Exhibit 1; and

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

<u>SECTION TWO</u>: The Mayor and City Council of the City of Rochelle authorize the City Manager to accept the proposal of and execute an agreement with Turner's Custom Concrete, pursuant to its proposal, attached hereto as Exhibit 1, in a form subject to review and revision by the City Attorney.

<u>SECTION THREE</u>: If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, resolution, resolution, rule or regulation, the regulations of this Resolution will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Resolution in pamphlet form.

<u>SECTION SIX</u>: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
