About the MoPac South Environmental Study

The MoPac corridor between Cesar Chavez Street and Slaughter Lane is a critical link in our region, keeping South Austin and Hays County connected to major highways like Loop 360 and US 290, and providing access to downtown Austin. According to 2023 TxDOT traffic counts, this 8-mile stretch of MoPac attracts up to 200,000 cars and trucks per day. The growing population as well as residential and commercial development has led to increased traffic congestion. **If we do nothing to address congestion, drivers could spend longer traveling the corridor.**



Official Comment Period

Public engagement is paramount to the Agency and this project. From developing the evaluation criteria to making adjustments to potential solutions, we take every comment we receive seriously.

The official comment period for the Open House begins on Tues., Nov. 12, 2024 and lasts until Sun. Dec. 29, 2024. Comments may be submitted in person at the Open House, through the virtual open house, by email, or mail as noted above. Please note that any comments submitted through other channels or outside the comment period will not be considered part of the record for this public meeting.
