**PUBLIC NOTICE**  
**2025 CGSA Pipeline Integrity Testing Rider**

Texas Gas Service Company, a Division of ONE Gas, Inc., (the “Company” or “TGS”) hereby gives notice of rates to be charged from April 2025 through March 2026 under the Pipeline Integrity Testing (“PIT”) Rider applicable to the Central-Gulf Service Area (“CGSA”) incorporated and environs areas of Austin, Bee Cave, Buda, Cedar Park, Cuero, Dripping Springs, Georgetown, Gonzales, Hutto, Kyle, Lakeway, Lockhart, Luling, Marble Falls, Mustang Ridge, Nixon, Pflugerville, Rollingwood, Shiner, Sunset Valley, West Lake Hills, and Yoakum, Texas and in the environs area of Bastrop, Texas. The PIT Rider permits the Company to recover the cost of pipeline safety testing that the Company is required to perform by law.

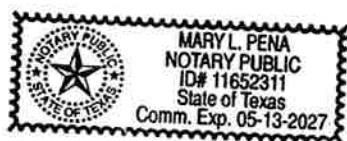
