11 12 13 14 15	WHEREAS , the City Council finds that the Travis Central Appraisal District has prepared, certified, and submitted to the tax assessor/collector the appraisal roll of the City of Rollingwood, Texas (the "City") for 2024; and
16 17 18	WHEREAS , the City Council finds that the 2024 certified appraisal roll represents the total appraised, assessed and taxable value of all property and the total taxable value of new property within the City as \$70,218,461; and
20 21 22	WHEREAS , the City Council finds the tax rate to be levied for 2024 (fiscal year 2024-2025) set by this ordinance is based on the appraisal roll and is sufficient to provide the tax revenues required by the City; and

39 40 41	NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLINGWOOD, TEXAS:
42 43 44	Section 1 . There is hereby levied an ad valorem tax of \$0.2058 on each \$100.00 of property within the City which is not exempt from taxation under the State constitution or State law. The general fund operating portion of the tax is \$0.1063. The debt service portion of the tax is \$0.0995.
