As for car thefts from Rollingwood, all that would cameras do is record the date, time and direction of the get away. Not much help. Also, just do not leave your fob in the car. Finally, the owners have insurance so they are made whole.

So on to the other seven total crimes, who knows if the cameras would help with apprehension. Those could be done by a resident (maybe even a teen).

On the other side of the equation we have over 400 homes with a low estimate of two drivers per home. Let's say they come and go to work, run a couple errands. Low estimate 3 trips per day. That is 2400 trips a day times 365 days so 876,000 totally legal camera views that would captured annually in attempt to stop 7 crimes.

These images will be saved forever on a server and available for subpoena from a government or private party in civil litigation. This is just too much an invasion of our privacy for almost no benefit. Please do not post cameras in our City. Thank you, Christopher Meakin 310 Nixon Drive

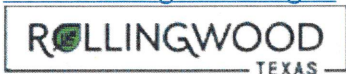
