

RESOLUTION NO. 2025-11-17-02

A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD NOVEMBER 4, 2025, FOR THE PURPOSE OF REAUTHORIZING THE ADOPTION OF A LOCAL SALES AND USE TAX AT THE RATE OF ONE-FOURTH OF ONE PERCENT TO PROVIDE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS

WHEREAS, under and by virtue of Ordinance No. 2025-07-16-09, duly passed by the City Council of the City of Rollingwood, Texas on July 16, 2025, and thereafter published in accordance with the law, an election (the “Special Election”) was held in the City of Rollingwood on November 4, 2025, for the purpose of reauthorizing the adoption of a local sales and use tax at the rate of one-fourth of one percent to provide for maintenance and repair of municipal streets; and

WHEREAS, there came on to be considered the returns of a special election held on the 4th day of November 2025 for the purpose of reauthorizing the adoption of a local sales and use tax at the rate of one-fourth of one percent to provide for maintenance and repair of municipal streets; and

WHEREAS, it appearing from said returns, duly and legally made, that there was cast at said election 335 total valid and legal votes; and

WHEREAS, the voters for the City of Rollingwood did pass and approve the reauthorization of a local sales and use tax at the rate of one-fourth of one percent to provide for maintenance and repair of municipal streets

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ROLLINGWOOD, TEXAS, SITTING AS THE GOVERNING BODY OF SAID CITY, THAT:

Section 1: That the Special Election of the City of Rollingwood, Texas held November 4, 2025 was duly called, that notice of such election was given, and that such election was held in accordance with law.

Section 2: That the tabulation of votes cast for the purpose of reauthorizing the adoption of a local sales and use tax at the rate of one-fourth of one percent to provide for maintenance and repair of municipal streets made and certified to by the City Secretary of the City of Rollingwood, Texas, be and the same is hereby adopted as the official tabulation filed and recorded in the official records of the City of Rollingwood as the official canvass of said election.

Section 3: That the proposition on which the vote was held reads as follows:

Proposition A. The reauthorization of the local sales and use tax in the City of Rollingwood at the rate of one-fourth of one percent to provide for maintenance and repair of municipal streets. The tax expires on the fourth anniversary of the date of the election unless the imposition of the tax is reauthorized.

Section 4: The official canvass of the returns of said election reflect the following:

For 290 Against 45

Section 5: That all of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.
