The Strike Force and Sean Garretson discussed elements of the draft Future Land Use chapter relating to residential and Bee Caves Road.

4. Discussion and possible action on single family and residential

The Strike Force discussed landscaping requirements and City Administrator Amber Lewis stated that the city does not currently have a residential landscaping ordinance.

Assistant City Administrator Ashley Wayman stated that Buie would have the analysis of the survey results that pertained to the city's residential area before the next meeting.

5. Discussion and possible action regarding future meeting dates and topics for the Comprehensive Plan Strike Force

Chair Thom Farrell stated that the Strike Force would be meeting next Monday.

The Strike Force discussed the remaining chapters of the Comprehensive Plan.
