CALL COMPREHENSIVE PLAN STRIKE FORCE MEETING TO ORDER

1. Roll Call

Chair Thom Farrell called the meeting to order at 4:00 p.m.

Present Members: Chair Thom Farrell, Ronald Hasso, Mo Goyal, Wallace Graner, David Smith and Ryan Clinton.

Also Present: City Administrator Amber Lewis, Assistant City Administrator Ashley Wayman, and Development Services Director Carrie Caylor.

4. Discussion and possible action to review and approve elements of the Comprehensive Plan

Sean Garretson, with Pegasus Planning and Development, discussed the status of the Economic Development chapter, Facilities and Infrastructure chapter, other chapters that have been previously reviewed by the Strike Force, and the information regarding utility capacity.

David Smith joined the meeting during this item.

Thom Farrell stated that he would be contacting Sean Garretson regarding the Facilities and Infrastructure chapter and history section.

Sean Garretson stated that he is working on the Future Land Use and Mobility chapters. The Strike Force discussed that Ryan Clinton would edit the Future Land Use chapter and David Smith would edit the Mobility chapter.

Ryan Clinton joined the meeting during this item.

Thom Farrell stated that he would ask David Raymond to help edit the Parks and Recreation chapter.

The Strike Force discussed that Mo Goyal and Ryan Clinton would work on the Residential and Single Family chapter, Brook Brown would look at the Economic Development chapter, and that Ronald Hasso would look at the current land use chapter.

The Strike Force discussed that they would review the implementation chapter before deciding who would edit it. They also discussed the process from here for completing the comprehensive plan.

5. Discussion and possible action on single family and residential

Chair Thom Farrell discussed the survey results relating to the city's residential area.

6. Discussion and possible action regarding future meeting dates and topics for the Comprehensive Plan Strike Force

Chair Thom Farrell stated that they would meet next week and that they would likely have final and semi-final drafts of each chapter.
