

1 **ORDINANCE NO. _____**

2 **AN ORDINANCE AMENDING ARTICLE II, DIVISION 2,**
3 **SECTION 107-69 (PROHIBITED USES) TO PROVIDE FOR**
4 **PROHIBITION OF RENTAL OF RESIDENTIAL AMENITIES;**
5 **PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.**

6 **WHEREAS**, the City of Rollingwood is a General Law Type A City under the
7 statutes of the State of Texas; and

8 **WHEREAS**, the City Council of the City of Rollingwood (“City Council”) wishes
9 to amend the City’s zoning regulations to prohibit the rental of residential and commercial
10 amenities; and

11 **WHEREAS**, the City Council has determined that the public interest would be
12 served by prohibiting the rental of residential and commercial amenities; and

13 **WHEREAS**, the City Council finds that the amendments provided for herein are
14 reasonable, necessary, and proper for the good of the City.

15 **NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY**
16 **OF ROLLINGWOOD, TEXAS, THAT:**

17 **SECTION 1.** All the above premises are hereby found to be true and correct legislative
18 and factual findings of the City Council and are hereby approved and incorporated into the
19 body of this Ordinance as if copied in their entirety.

20 **SECTION 2.** Code Amendment.

21 Section 107-3 of Definitions is amended to add the following definition:

22 Amenity. An indoor area or an outdoor area located anywhere on a lot, or
23 the roof of a structure, or any other building including but not limited to
24 pools, sport courts, patio areas, outdoor kitchens, grills, landscaped areas,
25 and areas of decking, decorative paving or other similar surface, used for
26 recreational purposes.

27 Section 107-69 (Prohibited uses), is amended to add a new Section 107-69(a)(7) as follows:

28 107-69(a)(7) The rental of any residential Amenity including but not limited
29 to any feature of a residential Dwelling, or place, except where the Amenity
30 is included as part of the rental of a Dwelling for longer than 30 days.

31 **SECTION 3.** All provisions of the ordinances of the City of Rollingwood in conflict with
32 the provisions of this ordinance are hereby repealed to the extent of such conflict, and all
33 other provisions of the ordinances of the City of Rollingwood not in conflict with the
34 provisions of this ordinance shall remain in full force and effect.

35 **SECTION 4.** Should any sentence, paragraph, sub-article, clause, phrase or section of this
36 ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not

37 affect the validity of this ordinance as a whole, or any part or provision thereof other than
38 the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity
39 of the Code of Ordinances as a whole.

40 **SECTION 5.** This ordinance shall take effect immediately from and after its passage and
41 the publication of the caption, as the law and charter in such cases provide.
