Subject: City Administrator's Report

Financials – Highlights of the financials through the month of April 2024:

• As of April 30, 2024, 58% of the Fiscal Year has passed.

- Property taxes collected were up 4% from the amount collected in April 2023.
- Sales taxes collected were up 26% % from the amount collected April 2023.
- The Water Fund balance is currently at \$1,279,070. The General Fund balance is at \$3,097,764.

In January, the City contracted with Ameresco to upgrade the city's existing utility meter infrastructure to electronic meters that feature automatic and electronic meter reads as well as a customer portal with access to consumption data and real-time alerts. We are happy to announce that the electronic meters have arrived and the City is nearly ready to transition into the meter replacement phase. Replacement of the electric meters will begin on Monday, June 3rd and will take one to two months. Ameresco has partnered with Ratliff Utilities to assist in the meter replacement throughout the city. Public Works began city-wide street sweeping at the end of April and will finish up this week. Street sweeping is performed twice a year in the spring and fall. We appreciate the community's cooperation in keeping the streets free of vehicles and garbage receptacles during scheduled sweeping times. Our Public Works team has done a fantastic job performing this service in-house to guarantee the best job done for our city!

On May 8, the Central Texas Regional Mobility Authority held a Technical Working Group (TWG) Kickoff meeting, beginning a series of TWG meetings that will focus on different subject areas relating to the MoPac South Project. The current topics are parkland, bike/pedestrian, water quality, cultural & historical resources, and utilities. These TWG meetings will be held throughout May and into June, and the city has been invited to send attendees that may have particular expertise in these areas. The City's MoPac South Expansion Task Force has been kept informed of these meetings and will be participating in the TWG meetings along with city staff.

Construction activities are ongoing for Water CIP Bond Program Packages 1-4. The Hubbard/Hatley/Pickwick and Nixon/Pleasant Drainage Projects are also slated for construction in the coming months.
