Description of the Mark

The mark consists of a stylized large "R" with a low sweeping front leg; to the right of the "R" is a stylized leaf with the top of the leaf being angled away from the "R" at about a 45 degree angle. The bottom of the stem of the leaf is positioned near the bottom end of the low sweeping front leg of the "R", and the top of the leaf is even with the top of the "R". The letters "TX" are located to the right of the end of the sweeping front leg of the "R" and below the leaf; the letters "TX" are in a much smaller font size than the large "R".

Without waiving any right at common law, no claim is made to the exclusive right to use "TX" apart from the mark as shown.
