As your Tax Assessor-Collector, I again look forward to working closely with you over the next few months to help establish your 2019 tax rates while insuring compliance with applicable tax laws. My staff and I are here to work with you and to help you through the Truth-In-Taxation process as best we can. The Truth-in-Taxation Dept., at 512 854 7969 or 512 854 3858, is your best contact on effective rate calculations. Tax revenue disbursement and reporting questions should be directed to our Accounting division at 512 854 3971. Please do contact me if there is any way we may improve upon our service to you.

In accordance with the terms of our service contract, I am required to inform you of the parcel fee rate (the per parcel fee we charge you for assessment and collection) adopted for this tax year. **You are hereby advised that the Travis County Commissioner's Court has established the 2019 assessment and collection fee at \$1.87 per parcel.** The 2019 rate is \$0.28 more than the current 2018 parcel rate of \$1.59.
