Chair Melissa Morrow shared an overview of the progress made for the Tree Planting Project as well as discussed the condition of the upper park parking lot along Rollingwood Drive. She stated that Alex Robinette created a proposed plan to improve the area.

Alex Robinette, resident at 2500 Hatley Drive, shared the details of her proposed modifications to the parking lot. She discussed the addition of parking spots, surfaces for parking, and taking away space from fields 3, 4, and 5.

The Park Commission discussed Ms. Robinette's proposal, concerns, coordination with approved projects, and the lease agreement. Chair Melissa Morrow requested staff to get feedback from City Council on the proposed parking improvements before perusing next steps in the tree planting project.

5. Discussion on potential improvements to the parking lot

Item 5 was discussed in conjunction with item 4.

6. Discussion on potential improvements and use of the fieldhouse at the upper park

Chair Melissa Morrow requested that the Park Commission members visit the fieldhouse before the next meeting and Alex Robinette shared her suggestions to potential modifications to enhance usability of the fieldhouse.

7. Discussion and possible action on potential park projects to be funded by the RCDC

Barry Delcambre, resident at 4 Westgate Circle and member of the RCDC, shared his thoughts regarding the proposed projects and would like to discuss them at the next RCDC meeting.

8. Update, discussion, and possible action on the Friends of Rollingwood Park Donation Opportunity

The Park Commission agreed to discuss this item at their next meeting.
