- If the price of fuel exceeds \$5, the price is subject to change.
- Due to no geotechnical report, Gage and Cade reserves the right to increase pricing if rock is encountered.
- Limited Warranty No replacements will be authorized or made without an inspection by Environmental Services staff. Warranty is limited to replacement only, not refund. All warranties will become null determined: failure to water properly, drought, freezing insect damage, abuse or mandated water restrictions imposed by local governments. It is the customers responsibility to maintain property if a m
- Existing Irrigation, Electrical, Drainage or other Underground Utility to be Repaired on T&M Cost.
- P.O.C. to be provided within 25 ft of planting area
- Permanent irrigation provided for plant material

All sums payable under this contract [or agreement] shall be paid to GAGE & CADE CONSTRUCTION, LLC at its offices located in BERTRAM, Burnet County, Texas.

The proper venue for any action hereunder, whether legal or equitable, shall be maintained in Bertram, Burnet County, Texas.
