7 8	WHEREAS , the City of Rollingwood is a General Law Type A City under the statutes of the State of Texas; and					
9 10 11	WHEREAS , the Texas Local Government Code Chapter 211 provides authority to regulate the height, number of stories, and size of buildings and other structures such as playhouses and playscapes; and					
12 13 14 15	WHEREAS, the City Council of the City of Rollingwood ("City Council") finds that scale and placement of playhouses and playscapes can impact the character of residential neighborhoods by affecting the spacing between structures, visibility from adjacent properties, and overall aesthetic harmony; and					
16 17 18 19	WHEREAS, the City Council finds and determines that playhouses and playscapes, particularly those of significant height or located near property lines, can impact the privacy and quiet enjoyment of adjacent properties by creating sightlines into private spaces and generating noise; and					
20 21 22 23	WHEREAS, the City Council finds and determines that unregulated placement or oversized playhouses and playscapes may create safety concerns, obstruct views, or lead to neighborhood disputes regarding setbacks, visual impact, and compatibility with surrounding structures; and					
24 25 26 27	WHEREAS, the City Council finds and declares that establishing reasonable regulations for the size and location of playhouses and playscapes is essential to maintaining the character of residential areas, minimizing conflicts between neighbors, and ensuring that such structures are safely and appropriately integrated within properties.					
28 29	NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLINGWOOD, TEXAS, THAT:					
30 31 32	SECTION 1. All the above premises are hereby found to be true and correct legislative and factual findings of the City Council and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.					
33 34 35	SECTION 2. Code Amendment. The following sections of the Rollingwood Code of Ordinances are hereby amended as follows with strikethroughs being deletions from the Code and <u>underlines</u> being additions to the Code:

Section 107-3 and 107-81 is amended as follows:

38	Playhouse means a freestanding building that is mostly enclosed and is
39	exclusively for children.
40	Playscape means a freestanding structure that is mostly unenclosed and is
41	exclusively used by children.
42	Sec. 107- 81 Playhouses and Playscapes.
43	(a) Playhouses and playscapes are exempt from regulations for accessory
44	buildings or structures, if they comply with the regulations outlined in
45	this subsection.
46	(b) Playscapes may be in a required side or rear yard.
47	(c) Playhouses less than six (6) feet in height may be in a required side or
48	<u>rear yard</u>
49	(d) Playhouses exceeding six (6) feet in height may be in a required side or
50	rear yard if all of the following conditions are met:
51	(1) The maximum height, measured to the topmost part of the
52	playhouse, does not exceed twelve (12) feet above natural grade;
53	(2) The maximum encroachment area does not exceed fifty (50)
54	square feet;
55	(3) The total area of the playhouse shall not exceed 120 square feet
56	in a required rear yard and fifty (50) square feet in a required
57	side yard; and
58	(4) The playhouse must be setback at least six (6) feet from any
59	property line.

62 63 64 65	SECTION 3 . All provisions of the ordinances of the City of Rollingwood in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and all other provisions of the City of Rollingwood ordinances which are not in conflict with the provisions of this ordinance shall remain in full force and effect.
66 67 68 69 70	SECTION 4. Should any sentence, paragraph, sub-article, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole, or any part or provision thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of the Code of Ordinances as a whole.

SECTION 5. This ordinance shall take effect immediately from and after its passage and

the publication of the caption, as the law and charter in such cases provide.
