8 **AND CANCELLING THE NOVEMBER 7, 2023 GENERAL**  
9 **ELECTION; REQUIRING THE CITY SECRETARY TO**  
10 **POST A COPY OF THIS ORDINANCE AT EACH CITY OF**  
11 **ROLLINGWOOD POLLING PLACE; AUTHORIZING**  
12 **CERTIFICATES OF ELECTION TO BE ISSUED;**  
13 **REPEALING ALL ORDINANCES OR PARTS OF**  
14 **ORDINANCES IN CONFLICT HEREWITH; PROVIDING**  
15 **FOR SEVERABILITY; PROVIDING A SAVINGS CLAUSE;**  
16 **FINDING AND DETERMINING THAT THE MEETING AT**  
17 **WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE**  
18 **PUBLIC AS REQUIRED BY LAW.**

20 **WHEREAS**, on July 19, 2023, the Rollingwood City Council issued an order  
21 calling for a General Election to be held in the City of Rollingwood on November 7,  
22 2023 for the purpose of electing three City Council Members to the Rollingwood City  
23 Council; and

25 **WHEREAS**, on July 24, 2023, Brook Brown filed an application for a place  
26 on the City of Rollingwood ballot for Council Member; and

28 **WHEREAS**, on July 24, 2023, Phil McDuffee filed an application for a place  
29 on the City of Rollingwood ballot for Council Member; and

31 **WHEREAS**, on July 25, 2023, Alec Robinson filed an application for a place  
32 on the City of Rollingwood ballot for Council Member; and

34 **WHEREAS**, on August 17, 2023, Genie Nyer filed an application for a place  
35 on the City of Rollingwood ballot for Council Member; and

36  
37 **WHEREAS**, on August 21, 2023, Amy Pattillo filed an application for a place  
38 on the City of Rollingwood ballot for Council Member; and

39  
40 **WHEREAS**, the filing deadline for an application for a place on the City of  
41 Rollingwood ballot was August 21, 2023; and

43 **WHEREAS**, the filing deadline for an application for a place on the City of  
44 Rollingwood ballot as a write in was Friday August 25, 2023; and

45  
46 **WHEREAS**, as of August 25, 2023, at 5:00 p.m. no individual had filed a  
47 declaration of write-in candidacy for a place on the ballot for City Council Member;  
48 and

49 **WHEREAS**, on August 25, 2023, Genie Nyer withdrew her candidacy from  
50 the November 7, 2023, election; and
