1. Roll Call

Chair Melissa Morrow called the meeting to order at 12:00 p.m.

She continued to discuss the City Council approved wording for the donation opportunity to be added to the utility bill message.

City staff and the Park Commission reviewed and discussed the proposed wording, changes to the wording, and recurrence of the bill message. The Commission also discussed website use, pushing out information about the donation opportunity, and next steps.

6. Discussion and possible action on next steps for the Rollingwood Park Tree Planting Project

Interim City Secretary Makayla Rodriguez stated that city staff reached out to contractors to request proposals as well as reaffirmed the proposal from Maas Verde Landscape Restoration for the Rollingwood Park Tree Planting project.

Don Hudson moved to accept Maas Verde's proposal by their most recent quoted number and recommend that City Council to review and approve. Diana Wallace seconded the motion. The motion carried with 5 in favor and 0 against.
