TAX LEVY ORDINANCE

AN ORDINANCE FOR THE PURPOSE OF LEVY, ASSESSMENT AND COLLECTION OF TAXES FOR THE CORPORATE AND MUNICIPAL PURPOSES OF THE VILLAGE OF ROSCOE, WINNEBAGO COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024.

WHEREAS, the duly elected President and the Board of Trustees of the Village of Roscoe, Winnebago County, Illinois have heretofore adopted an annual appropriation ordinance (Ordinance 2024-04) which was prepared and adopted in accordance with the Illinois Municipal Code (65 ILCS 5/8-2-9), and

WHEREAS, the Board of Trustees, at its November 19, 2024 meeting, established the estimated tax levy for tax year 2024 (to be collected in 2025) to be \$1,760,026.09 which is less than 105% of the final aggregate levy extension for the 2023 taxes of the Village; and

WHEREAS, in accordance with the Truth in Taxation requirements, the Village of Roscoe is not required to hold a public hearing on the proposed tax levy.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Roscoe, Winnebago County, Illinois:

SECTION 1: That the Board of Trustees of the Village of Roscoe has ascertained the total amount necessary to be raised by taxation during the year beginning January 1, 2024 and ending December 31, 2024 (to be collected in 2025).

SECTION 2: That the amount set forth below, or as much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the boundaries of Village of Roscoe as that property is assessed and equalized for the tax year 2024, with the amount levied for each object and purpose placed in a separate column and summarized for the year beginning January 1, 2024 and ending December 31, 2024 (2024 tax year) as follows:

REVENUE RECAPTURE	(35 ILCS 200/18-233)	\$14,526.29

TOTAL AMOUNT TO BE RAISED BY TAX LEVY: \$ 1,678,629.09

SECTION 4: That the Clerk of the Board of Trustees of Village of Roscoe shall make and file with the County Clerk of Winnebago County, on or before December 31, 2023, a duly certified copy of this ordinance, as required by 35 ILCS 200/18-15.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That all ordinances or resolutions or parts thereof in conflict herewith be and the same hereby are repealed and amended.

SECTION 7: That this ordinance shall be in full force and effect after its adoption, as provided by law.
