

**VILLAGE OF ROSCOE, ILLINOIS**  
**RESOLUTION NO. 2025-R48**

**RESOLUTION BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ROSCOE APPROVING A RIGHT-OF-WAY (ROW) USAGE AGREEMENT WITH COMCAST OF ILLINOIS/INDIANA/OHIO, LLC.**

**WHEREAS**, Comcast of Illinois/Indiana/Ohio, LLC (“Comcast”), wishes to expand its fiber internet service area into the Village of Roscoe; and

**WHEREAS**, the Village of Roscoe finds that it is in the best interest of its residents to encourage competition between fiber data service providers, and to provide for the regulation and orderly development of infrastructure within its rights-of-way; and

**WHEREAS**, Comcast has requested an agreement with the Village of Roscoe related to the maintenance and expansion of cable and telecommunications service and infrastructure in the Roscoe Village limits; and

**WHEREAS**, this agreement is not intended to supersede any ordinance of the Village of Roscoe, including the Village’s construction in rights-of-way ordinance, as it currently exists or as it may be amended from time-to-time; and

**WHEREAS**, the President and Board of Trustees of the Village of Roscoe believe it to be in the best interest of the Village and its residents to enter into such an agreement to encourage competition within the Village of Roscoe; and

**WHEREAS**, the Village is authorized to enter into such an agreement with Comcast; and

**NOW THEREFORE BE IT RESOLVED** by the President and Board of Trustees of the Village of Roscoe, that by the adoption of this resolution, the Village President is authorized to sign a right-of-way use agreement with Comcast of Illinois/Indiana/Ohio, LLC, such agreement which shall substantially reflect the findings set forth in this resolution and the proposed agreement set forth as Exhibit “A”.
