Retaining Wall

- Removal of existing retaining wall blocks and to set aside.
- Removal and disposal of existing base and backfill material.
- Excavation of proposed area for base prep.
- Installation of a minimum 8" CA-6 compacted gravel base.
- Installation of Unilock Olde Quarry wall block to construct new 110' retaining wall. Wall will be terraced to match existing layout. Highest part of wall will be 4-ft and lowest will be 2-ft.
- Installation of Geogrid fabric throughout retaining wall.
- Wall block will be secured in place using landscape adhesive and finished with a matching coping.
- Installation of 4" perforated drain-tile and 1" limestone chip behind wall for drainage.
