APPROVAL OF THE MINUTES

1. **Approval of the Minutes** for the meeting of the Village Board of Trustees from **October 7**, **2025**.

President Gustafson asked for a motion for the approval of the minutes.

Motion was made by Trustee Sima, second by Trustee Broda. Voting yes: Trustees Broda, Wright, Mead, Plock, Babcock, Sima.

2. Review and Discussion of **Hodges Run Small Business Incubator Bid** Responses

[Presented by: Joe Anderson of Place Foundry Design, LLC]

Village Board of Trustees Meeting Minutes - October 21, 2025 Joe Anderson Place Foundry presented updates on the Hodges Run small Business Incubator project, focusing on revised bid details and strategic recommendations. The base bid was adjusted to \$1.574 million after removing two components: the restrooms building and labor for popup shed installations, which had originally been included due to anticipated volunteer support that later fell through.

The Trustees debated whether to proceed this season or delay until the spring, with the consensus forming around postponement to avoid \$50,000. in winter-related costs for concrete protection and construction inefficiencies.

There was discussion on scaling back the number of popup units from 14 to 10, which could save roughly \$6000. - \$7000. per pad, and emphasizing the need for a clearer business model, phased implementation, and potential material donations before moving forward.

The board decided to postpone until spring, no vote needed.

3. Project Update on the **Rockton Road Corridor Study**

President Gustafson stated that Place Foundry has been contracted through December 31, 2025, to focus on development opportunities along Rockton Road Corridor. She stated that letters went out to significant property owners, and meetings are scheduled with those individuals to ask them what is it that they would like to see with their property and to share with them our road projects.

Place Foundry has prepared a market analysis for development scenarios and engineering plans for nearby roads.

Trustee Sima and Trustee Broda stated that they both had difficulties with opening the documents that were sent to them.

President Gustafson stated that Jeff Mackey of Place Foundry will be at the next board meeting with a presentation and for the board to ask any questions.

Trustee Wright stated that the price should be lower. He stated that he has 3 sponsorships and two more to go.

8. Action on awarding of the contract for the **Main & Bridge Street Pedestrian Crosswalk Project**

[Recommendation from Committee of the Whole is to reject all bids and not move forward with awarding project Vote: 5-0-1 /COTW /10/07/2025]

President Gustafson asked for a motion for approval of the Main and Bridge Street Pedestrian Crosswalk project.

Brandon stated that there are other roads that need striping done as well, which should be done this year or next year.
