VILLAGE OF ROSCOE ORDINANCE NO. 2025-04

AN ORDINANCE AMENDING SECTIONS SEC. §15-555 OF THE VILLAGE OF ROSCOE CODE OF ORDINANCES PERTAINING TO PRIVATE SOLAR ENERGY COLLECTION SYSTEMS.

- **WHEREAS**, §15-555 of the Village of Roscoe's Code of Ordinances establishes general construction standards Private solar energy collection systems; and
- **WHEREAS,** the President and Village Board wish to amend such construction standards, and such a change in the Village's zoning code requires a text amendment to the Village's zoning ordinance; and
- **WHEREAS**, on December 11, 2024, the Village of Roscoe Zoning Board of Appeals held the requisite hearing pursuant to notice regarding the proposed text amendment; and
- **WHEREAS**, on December 11, 2024, the Zoning Board of Appeals voted to approve and recommend the proposed text amendment; and
- **WHEREAS**, the Village of Roscoe is authorized and empowered by statute to adopt and enforce the provisions of this ordinance; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSCOE, WINNEBAGO COUNTY, ILLINOIS AS FOLLOWS:

- **Section 1.** The foregoing recitals are incorporated herein as findings of the Village of Roscoe Board of Trustees.
- **Section 2.** Section §15-555 of the Village of Roscoe Code of Ordinances is hereby <u>Amended</u>, to reflect the amendments set forth herein:
