# **PUBLIC COMMENT (Limited to 3 minutes per speaker)**

Terry Brock, a resident of Roscoe, expressed gratitude for the new pedestrian crossing flashing lights, and thank Troy and Public Works. Mr. Brock and raised concerns about the enforcement of a village ordinance regarding the placement of a utility trailer on his property after living in Roscoe for over 36 years. He is using the trailer multiple times throughout the time and recent received a violation from the Village. Mr. Brock would like to see fairness in enforcement and suggested that the code enforcement officer could have introduced himself better. Mr. Brock expressed his frustration with the citation and stated he will be watching to ensure everyone is treated fairly.

# PRESIDENT'S REPORT

President Gustafson provided Troop 6222 with general comments on the obligations, duties, and rights of US Citizens. # 2. Presentation: Introduction to Marshmallow's Hope

Laura Kane and Jill Diederich will present on Marshmallow's Hope's mission to support mental health and suicide prevention by destignatizing mental health issues, offering support to those struggling, and fostering resilience for survivors and families.

President Gustafson introduced Marshmallow's Hope;

Laura Kane founder and CEO, Jamie Kuney Director of Operations, Jill Diederich Peer Support and Holley Hulmes Youth Mentor.

Laura Kane provided overview of the program, stating in 2018 Ms. Kane lost her son to suicide. Ms. Kane stated 1 in 5 live with mental illness. Marshmallow's Hope is the voice for those who feel they don't have one. Marshmallow's Hope believes in the power of compassion, connection, and hope will aid in the creation of bonds that will empower those they serve to build trust, overcome challenges, and create pathways to perseverance. Marshmallow's Hope strives to prevent suicide by eliminating access barriers to care, facilitating mentorship programs, and connecting our clients to a comprehensive offering of support groups through our community partners – and providing graceful postvention support accepting those on their path to resilience. All Services are pro bono, and they service six counties: JoDaviess, Ogle, Stephenson, Winnebago, Boone and McHenry.
