

**VILLAGE OF ROSCOE, ILLINOIS  
ORDINANCE NO. 2024-12**

**AN ORDINANCE APPROVING AN ANNEXATION TO THE VILLAGE OF ROSCOE OF PROPERTY LOCATED AT 13000 AND 13019 NORTH SECOND STREET, ROSCOE, ILLINOIS (PINS: 04-21-151-004, 04-21-151-005) WITH VILLAGE OF ROSCOE LIGHT INDUSTRIAL DISTRICT (IL) ZONING**

**WHEREAS**, the Village of Roscoe is a duly-authorized Illinois municipal corporation operating under the provisions of the Illinois Municipal Code (65 ILCS 5/1-1, et.seq.);

**WHEREAS**, the owners of the property located at 13000 and 13019, North Second Street, Roscoe, Illinois (PINS: 04-21-151-004, 04-21-151-005), have petitioned the President and Village Board of Trustees of the Village of Roscoe, to annex said property into the territorial boundaries of the Village; and

**WHEREAS**, legal notices regarding the intention of the Village of Roscoe to annex said territory have been sent to all public bodies required to receive such notice by State Statute; and

**WHEREAS**, copies of such notices required to be recorded, if any, have been recorded in the office of the Recorder of Deeds of Winnebago County; and

**WHEREAS**, a public hearing to consider the proposed Annexation and Zoning was held on November 13, 2024, at 5:30 p.m. at the Roscoe Village Hall, 10631 Main Street, Roscoe, Illinois; and

**WHEREAS**, all petitions, documents, and other necessary legal requirements are in full compliance with the statute of the State of Illinois, specifically, 65 ILCS 5/7-1-13, et. Seq., as amended; and,

**WHEREAS**, it is in the best interests of the Village of Roscoe, Winnebago County, Illinois, that said territory be annexed thereto.

**NOW THEREFORE BE IT ORDAINED** by the President and Board of Trustees of the Village of Roscoe, that:

**Section 1.** The foregoing recitals shall hereby be incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2.** That the following described territory, being indicated on an accurate map of the annexed territory, which is appended hereto and made a part of this Ordinance, be, and is hereby annexed to the Village of Roscoe, Winnebago County, Illinois:

- Section 3.** That the map amendment request by the owner of the property located at 13000 and 13019 North Second Street, Roscoe, Illinois (pins: 04-21-151-004, 04-21-151-005), as described in the description attached hereto as Exhibit A, be and hereby is approved, and shall be zoned Light Industrial (IL) as described in the Village of Roscoe Code of Ordinances, and such property shall be held to such Village Zoning Regulations, prior to and following annexation.
- Section 4.** That the Village Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed and appended to said Ordinance.
- Section 5.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
