They are looking to open Lucky Slots down street location 10774 Main Street, Roscoe. Applicant provided an overview of the location as well as outline of what it will look like. Rose addressed location as well as the distance between them and church, they have agreed to open after church on Sundays. Administrator Sanders provided overview of the building as well as the parking. Trustee Keene inquired about the handicap parking,

and location. Rose provided identification of the location for the parking. Trustee Keene inquired about the landscaping, and Rose stated it will be appealing, and she does not have the specs and designs for it.
