RESOLUTION NO. 2025-R14.1**

**A RESOLUTION AMENDING RESOLUTION 2025-R14, AND APPROVING THE  
PURCHASE OF TWO 72 KUBOTA ZERO TURN RADIUS MOWER FOR USE BY  
THE VILLAGE OF ROSCOE PUBLIC WORKS DEPARTMENT**

**WHEREAS**, the Village of Roscoe wishes to protect the health, welfare and safety of its residents by providing well maintained roads, parks, and other public places, and a provide for a safe and well-equipped public works department; and

**WHEREAS**, the Village of Roscoe is in need of a two (2) new zero turning radius mowers for use by the Village of Roscoe Public Works Department; and

**WHEREAS**, the Village of Roscoe has put out for bid, under the auspices of National Joint Powers Alliance (Sourcewell) contract, specifications for two ZD1611LF-72 Kubota Zero Turn Radius Mowers, as further specified set forth in Exhibit “A”, which is incorporated herein by reference; and

**WHEREAS**, the President and Board of Trustees of the Village of Roscoe find that it is in the best interest of the Village and its residents to purchase said ZD1611LF-72 Kubota Mowers as provided for in the JNPA Joint Purchase Agreement, from Bobcat of Rockford; and

**WHEREAS**, on **April 15, 2025**, the Village Board of Trustees approved the purchase of said mowers, however, due to an error in the quote, the Village was incorrectly being credited for a trade in of two mowers, rather than the single mower being traded in by the Village, therefore, resulting in a \$5000 difference in the previously approved expenditure; and

**WHEREAS**, the Village of Roscoe is authorized and empowered by statute to adopt and enforce the provisions of this resolution.

**NOW THEREFORE BE IT RESOLVED** by the Board of Trustees of the Village of Roscoe, that:

**Section 1. Resolution 2025-R14, is hereby amended, and superseded, so as to reflect the corrected quote attached as Exhibit “A”.**

**Section 2.** The Village President, is authorized to sign an agreement with **Bobcat of Rockford, IL** for the purchase of two new ZD1611LF72 Zero Turn Radius Mowers, as further specified set forth in Exhibit “A”, which is incorporated herein by reference, for use by the Village Public Works Department, for an amount not to exceed **\$40,000.**

**Section 3.** That the Village Treasurer is hereby authorized, and instructed to expend funds, and issue payment in an amount not to exceed **\$40,000.**, under the terms and amounts as set forth in Exhibit “A”.
