President Gustafson summarized the recommendation of increasing the Video Gaming Terminal License fee.

Public Act (PA) 102-0689 allows non-home rule municipalities to impose an annual fee for the operation of each video gaming terminal not to exceed \$250 per year. Currently, the cost is \$25 per machine, however, the Village under this act may raise the fee to \$250 per machine. The renewal starts July 1, 2025.
